Dear Parents and Carers,

Thank you to all our parents and carers who have worked with us over the course of the past week as we introduce our additional measures to keep you and your children safe while on our site. The way in which the changes have been managed by the St Nicholas team has been exceptional and I would like to offer my continued thanks to everyone for making things work so smoothly.

Since Wednesday this week the following measures have been enforced:

- No more than one adult per family will be allowed onto the school site to drop off or collect their child.
- Parents must leave the school site promptly and not wait in the school grounds.
- Children **must not** play on the equipment in the grounds at home time
- No secondary school age children will be allowed onto the school site unless they are collecting a sibling.
- Families MUST adhere to the drop off and collection times for their child. Teachers will be asked to monitor this situation more closely moving forward.

This week I've been looking at the progress tests undertaken by many of the older children to see what additional measures we are able to introduce to support our pupils for the time they were not at school over the lockdown period.

It will come as no surprise that some of the initiatives we would like to put in place will involve you as parents. Normally we would ask parents to come into school and share our ideas on how you can support your child. Obviously, we are not in a position to do this, so we will be writing to parents with ideas on supporting homework along with videos placed on the website. Please watch out for information on supporting your child with RWI Phonics, reading and our Talk 4 Writing over the coming weeks.

Safeguarding statement

At St Nicholas our core responsibility is for the safety and well-being of the children in our care. As such we take our responsibility for safeguarding including our statutory responsibilities, very seriously. Only if children are safe and happy are they able to fulfil their potential in their learning.

We achieve this objective by:

- Establishing a safe environment in which children can learn and develop.
- Supporting pupils who have been abused in accordance with his/her agreed child protection plan.
- Raising awareness of child protection issues and equipping children with the skills needed to keep them safe. Pupils are taught about safeguarding as a part of the national curriculum through PSHE, SRE and Religious Education.
- Developing and then implementing procedures for identifying and reporting cases, or suspected cases, of abuse.
- Ensuring we practise safe recruitment in checking the suitability of staff and volunteers to work with children.
- Staff development and learning to recognise children in need of protection.

Safeguarding is Everyone's Responsibility

In order to safeguard and promote the welfare of children, the school will act in accordance with the following guidance:

Keeping Children Safe in Education 2020

We have a number of policies in place that contribute to our safeguarding commitment including our Child Protection and Online Safety policies. All our policies can be viewed in the Policies section of the school website. We take the safety of our children very seriously, both in the real world and online. You can find out more about E-Safety in the Online Safety section of our website.

What is Safeguarding and Child Protection?

Safeguarding and promoting the welfare of children is defined as protecting children from maltreatment; preventing impairment of children's health or development; ensuring that children grow up in circumstances consistent with the provision of safe and effective care; and taking action to enable all children have the best outcome.

Child protection is the protection of children identified as either suffering, or likely to suffer, significant harm as a result of abuse or neglect.
